4) **BREEDING.** Client contracts to breed this Mare to **MARAJJ** during the 2006 or 2007 breeding season which terminates on August 15, 2006 or 2007. The Stallion will stand at Brookville Arabians LLC. The stud fee is \$5,000 , this includes a non-refundable handling charge of \$ 500 , the handling fee is due and payable upon execution of this Contract. **The balance of the stud fee must be paid prior to the first shipment of semen.** Client has read, understands and agrees to all the terms and conditions of this agreement.

5. **LIVE FOAL GUARANTEE.** Brookville Arabians LLC guarantees a return breeding the following season should a Live Foal (defined as one who stands and nurses without assistance) not result from this breeding. Death of the foal before qualifications as a Live Foal must be certified in writing by a veterinarian and received by Brookville Arabians LLC within ten (10) days of live foaling date. A Rhinopneumonitis series must be completed for the Live Foal Guarantee to apply. Written documentation may be required in the event of an aborted or dead foal.

6. **STALLION GUARANTEE AND PROMOTION.** Should said Stallion be unavailable for medical reasons including fertility, as substantiated by a veterinarian, or by death, the parties agree that the Client shall have the option of breeding to another stallion owned or leased by Brookville Arabians LLC. If Client does not wish to breed to the replacement stallion offered, the Client's breeding is null and void and all fees are non-refundable. Client agrees that Brookville Arabians LLC may, at its discretion, show or promote Stallion during normal breeding season.

7. **LIMITATION OF LIABILITY AND INDEMNIFICATION.** Regardless of any negligence on its or their part, Brookville Arabians LLC and their subsidiaries, affiliates, breeding managers, agents, servants and employees shall not be held liable for any sickness, disease, estray, theft, death or injury suffered, nor for any other loss, damages or injury arising out of or connected with breeding, or other services pursuant to the Contract, except as required by law. Client fully understands, authorizes and assumes the special risks inherent in breeding, and acknowledges that mortality and other insurance is solely Client's responsibility. ALL implied warranties, including fitness, merchantability or otherwise, and all special, incidental and consequential damages are hereby excluded, to the full extent permitted by law. In no event shall Client's remedy exceeds the amount of the fee by law. In no event shall Client's remedy exceed the amount of the fee paid for service complained of Brookville Arabians LLC shall also not be held liable for any personal injury or disability, which the Client or his agents, representatives or family may receive while on Brookville Arabians LLC premises where horse is standing. Client agrees to indemnify and hold Brookville Arabians LLC where the stallion is standing harmless for, from and against any claim, damages, illnesses or injury caused or suffered by the Horse, and from any claim by a buyer of the Horse, and Client agrees to pay all expenses and attorney's fees incurred by Brookville Arabians LLC where the stallion is standing in defending any such claim.

8. **NONASSIGNABILITY.** Client may not assign any rights or delegate any duties under this Contract without the written consent of Brookville Arabians LLC.

9. **REBREEDING.** Mares not checked in foal in a given year may be rebred in the next consecutive year for a rehandling fee of \$400.00. If no attempt to rebreed is made in the following consecutive year Brookville Arabians may, at its sole discretion, terminate the Breeding Contract or require substitution of the mare. In this event the rehandling fee will be \$600.00

10. **ENTIRE AGREEMENT, CONSTRUCTION, JURISDICTION. AND ATTORNEY'S FEES.** This Contract contains the entire understanding of the parties concerning its subject matter and may be modified only in writing. Headings are for convenience only and not part of this Contract. The invalidity or unenforceability of any

term or provision shall not affect the validity or enforceability of the remainder. This Contract shall be construed and governed by the laws of Arizona. Jurisdiction and venue for all disputes connected with this Contract shall be proper only in Maricopa County, Arizona. If a lawsuit is filed with respect to this contract, the prevailing party shall be entitled to collect all reasonable attorneys' fees and costs.

TRANSPORTED SEMEN AGREEMENT**

Whereas, Client has purchased a \_\_\_\_\_ breeding for the Mare to \_\_\_\_\_ desires to have live-cooled semen shipped to Client using the Equitainer method to satisfy said breeding right. NOW, THEREFORE, THE PARTIES HEREBY AGREE that Brookville Arabians LLC will have the semen shipped from \_\_\_\_\_ to Client for the Mare on the following terms and conditions:

1. Stallion booking fee or rehandling fee must be paid in advance.
2. A one way transport fee per shipment must be paid to Brookville Arabians LLC. Each Federal Express shipment is \$250; same day shipping by air is \$350; and same day Federal Express will be at cost (approximately \$500).
3. The Client must return the Equitainer by Federal Express Priority Overnight mail to arrive at Brookville Arabians LLC no later than 3 days after Client's receipt. Client shall pay a \$25.00 a day charge if the Equitainer is not received within that time period and subsequent shipments of semen will not be made until the container is returned. Return shipping charges for the Equitainer (Federal Express Priority) shall be paid by the Client.
4. The Client shall notify Brookville Arabians LLC of the impending need for semen by telephone or FAX on the 1<sup>st</sup> day of Mare's heat cycle.
5. THE CLIENT SHALL NOTIFY BROOKVILLE ARABIANS LLC WITH A MINIMUM OF 48 HOURS NOTICE PRIOR TO SHIPMENT OF SEMEN. ORDERS MUST BE PLACED BY 10:00 A.M. CST TWO DAYS BEFORE SHIPMENT.
6. ROUTINE COLLECTION OF THE STALLION IS SCHEDULED FOR MONDAY, WEDNESDAY, AND FRIDAY OF EACH WEEK WHICH SCHEDULES SEMEN DELIVERY FOR TUESDAY, THURSDAY, AND SATURDAY.
7. Priority in semen transport will be given to those who book earliest and who give 48 hours advance notice (before 10:00A.M. PST two days before semen is scheduled to be shipped).

6. Payment of the balance of the stud fee prior to the first semen shipment. Check to be made payable to BROOKVILLE ARABIANS LLC.
7. A \$250.00 refundable deposit for the equitainer is required prior to shipment of semen (a credit card number is acceptable).
8. Should the client not return the equitainer to Brookville Arabians LLC within three working days from client's receipt of said equitainer, the client's account will be charged \$25.00 a day late fee. Should the equitainer not be returned to Brookville Arabians LLC within a 2 week period, the client's account will be charged \$500.00.
9. A flat rate for lab, processing and Federal Express shipping fees is charged every time semen is shipped. (\$250 Federal Express overnight service; \$350 same day shipping by Air; and same day Federal Express will be at cost, approximately \$500).
10. The cost of shipping for returning the equitainer to Brookville Arabians LLC will be paid by owner.
11. Mare owners must notify Brookville Arabians when their mare comes into heat cycle in which they intend to breed.
12. A minimum of 48 hours notice is needed prior to shipment of semen, and orders must be placed by 10:00A.M. PST.
